

VIC-2 "disclosed being sexually abused by multiple men who come to the home "to play games with her." VIC-2 "said this occurs in a "jail." "She described a room with a bed, chains, and handcuffs. The reporting party suspects this is actually a shed located in the back of the home." "Mr. Harris is known to participate in a sex club called the Red Dragons. The children said the other members refer to him as "Master Bobby." "... reporting party believes some of the men involved in the club are members of law enforcement." "... reporting party said she already filed a report in San Bernardino County on behalf of ..." VIC-2 and VIC-1.

Referral 0577-0884-0843-5083354 was generated on 12/04/2015 at 1952 hours and the reporting party was a Superior Court of California (Murrieta) employee. The referral was a result of a 3027 Hearing Request. The allegations were Sexual Abuse and General Neglect

SAN BERNARDINO CFS REFERAL:

Referral 1539-6057-6062-7052782 was generated on 11/24/2015 at 1906 hours and the 2 reporting party was a Kathleen Huerta, Kaiser Permanente Hospital, Riverside. The allegations listed in the referral were as follows: "The caller is reporting allegations of sexual abuse by unknown and general neglect by father to..." VIC-2 and VIC-1. "Mother stated the following and the RP: On Monday" VIC-1 "told her there are a lot of naked people in father's home, he is made to touch their private parts, they grab his hand and put it on their private parts, he is made to kiss their private parts, but he was not made to take his clothes off. Per mother, within the last year" VIC-2 "behavior has changed, and has talked about suicide." "The RP spoke to "VIC-1 "who said no one has touched his private parts, but he was made to touch the adult's private parts." "The RP spoke" to VIC-2 "who said last Wednesday" VIC-1 "touched her in her private area, no one is touching her inappropriately, no one is touching Malachi, and no one if [sic] forcing" VIC-1 "to touch anyone."

BACKGROUND:

On 11/24/2015 at 1506 hours, Deputies Jackson #3603 and Cox #5027 were assigned to assist Child Protective Services (CPS) with an alleged sexual assault investigation at 13876 Fair Meadows Court, Eastvale, County of Riverside. Upon arrival at the location the deputies contacted Child Protective Services (CPS) Social Worker (OTH) Olivia Baker and another SW who told them she had received a referral reference sexual abuse allegations involving (SUS-1) Bobby Harris and his girlfriend (OTH) Crystal Turner. The deputies accompanied the social workers into the residence and observed the home inspection. The entire house was checked to include the shed in the backyard. The garage was not checked due to it being locked and inaccessible. Bobby explained to CPS/Deputies the garage was locked due to construction materials being inside the garage and his neighbor had the only key. The neighbor would let the workers into the garage. This construction was due to a water leak which had occurred on the second floor of the residence. Nothing unusual was located inside the residence or in the shed.

The deputies also observed the interviews the social workers conducted with Bobby, Crystal and Crystal's two children, and and Crystal's children. Crystal's children live with Bobby and her full time while Bobby's children, VIC-1 and VIC-2, are with them part time. After the interviews Baker advised the deputies she would be writing a report, but did not see any signs of abuse. Deputy Cox did not hear anything that appeared "criminal in nature" and advised Bobby and Crystal a report would be written.

On 11/24/2015 at 2112 hours, Deputies Jackson and Cox were dispatched to Kaiser Permanente Hospital, Riverside, County of Riverside, reference a past sexual assault occurring at 13876 Fair Meadows Court. Upon arrival at the hospital they contacted the hospital social worker who made the report. The worker stated the mother of the victims, (OTH) Angelina Harris, of VIC-1 (Male/7 yrs. old) and VIC-2 (Female/5 yrs. old) stated the children had been sexually abused by Bobby Harris (later identified as biological father). The social worker had spoken to VIC-1 and he did not tell her anything about being touched sexually. The worker also stated it appeared the victims had been "coached." At 2112 hours, the deputies met with Angelina and both victims in examination room ten located in the Pediatric Center, Kaiser Permanente Urgent Care Unit. Angelina consented to the deputies speaking to the children without her being present.

Without Angelina present, Deputy Jackson spoke with VIC-1 (VIC-2 was not present) and he stated he knew the difference between the truth and a lie. He also knew what his private parts were and where they are located. Deputy Jackson asked VIC-1 if anyone had ever touched his private parts and he replied, "No." VIC-1 appeared cheerful while speaking with Deputy Jackson. Deputy Jackson asked VIC-1 a second time if anyone had ever touched his privates and he replied, "No."

Deputy Jackson spoke with VIC-2 and asked if anyone had touched her private parts. She replied, "Yes, daddy does. He makes me, but I don't want to." Deputy Jackson asked VIC-2 who told her that and she said, "My mommy." Deputy Jackson asked VIC-2 if she would be sad if she never saw her dad again and she replied, "No, I would be happy. He always does mean things to me." Deputy Jackson asked her what kind of mean things he does to her and she said, "I don't

- know. I don't remember." Deputy Jackson asked VIC-2 if her dad touched her private parts and
- 2 she said he touched her vagina. Deputy Jackson asked VIC-2 how long he touched her vagina
- and she described it as a quick tap. Deputy Jackson asked VIC-2 if she wanted to see her dad go
- 4 to jail and she replied, "Yes." Deputy Jackson asked if she knew Crystal and VIC-2 said she did.
- 5 VIC-2 said Crystal "touched me the same way daddy did." While VIC -2 was speaking with
- 6 Deputy Jackson, Deputy Cox observed VIC-2 appeared "unconcerned."

The deputies contacted Angelina who stated there had not been any signs of sexual abuse while she and Bobby had been married, but there were some signs with VIC-2 after they separated. Angelina said Bobby has a sex addiction that he has seen a counselor for. Angelina stated VIC-2 described Bobby's penis and used her arm to show how big his penis was. VIC-2 also told Angelina she "has had to put her mouth on [Bobby's] penis. Deputy Jackson asked

Angelina if she told VIC-2 Bobby was going to jail and she said she had not.

DETAILS:

On 11/25/2015, I was assigned this investigation and read the initial report by Deputy Cox, which described the events on 11/24/2015. (I also read the CPS referral. I was unable in my search of the internet to locate a sex club called the Red Dragons. On 12/09/2015, I contacted Angelina and asked her to transport her children, VIC's 1 and 2, to Project Kids on 12/14/2015 so they could be interviewed at 1000 hours. I explained the interview process to her and she agreed to have the children there at the appointed time. On 12/11/2015, I received a supplemental report from Deputy Jackson which described her follow-up at 13876 Fair Meadows to check the garage. (It was later learned Bobby had removed all the construction material and dumped them by utilizing a U-Haul rental truck.) Deputy Jackson observed the garage had been converted into a workout area and contained weights, a television and various other workout equipment. Deputy Jackson did not observe anything that appeared suspicious. On 12/10/2015, Deputy Jackson received an email from Bobby that contained text messages and other information detailing dealings with his ex-wife, Angelina.

On 12/14/2015, VIC-1 and VIC-2 were interviewed at Project Kids by SW Jackie Saldana. Besides myself, also present were Riverside CPS SW Olivia Baker and San Bernardino Child & family Services (CFS) SW Cole Taylor. Olivia advised me she and Cole went to Angelina's residence in Rancho Cucamonga on 12/07/2015 and interviewed both victims. Olivia further stated while at the residence Angelina had been upset by the response of CPS and CFS to the allegations and had begun her own investigation. Angelina had spoken with VIC-2 about the other men involved and conducted a Facebook search and showed individuals to VIC-2 who confirmed they had been in Bobby's residence. Angelina stated she did not believe Bobby would do anything to the children, but believed her children's disclosures. Olivia told me while Angelina was speaking with them. VIC-2 was observed going up and down the stairs at the residence. As VIC-2 would get closer Angelina would raise her voice and when VIC-2 went back up the stairs her voice would not be as loud.

VIC-1 disclosed he was told to touch Crystal's butt and breast area and was told to touch his father's penis. VIC-2 disclosed she was told by her father to touch herself and that her father touched her. Both victim's said these acts only occurred in the master bedroom at the residence. VIC-2 disclosed she believes VIC-1 was touched because she heard her brother talking about it with their mother while in the car. When the children were asked for specific details regarding the allegations they both answered they didn't remember or they didn't know.

Both Cole and Olivia stated to me they felt the children had been coached reference their statements. Also, Olivia told me the children never mentioned anything about a sex club called the Red Dragons, sex acts with other adults, or anything to do with whips and chains.

RCCAT VIC-1

26 The following is only a synopsis of VIC-1's interview. Refer to the DVD for detail. VIC-1 disclosed Crystal put his cheeks, hair and head on her "booty." Later during the interview VIC-1 27 also added "boobs" when describing what occurred with Crystal. This occurred two times and in 28 the restroom at the residence. VIC-1 could only say it occurred when he was seven and in the second grade. The first incident occurred before his birthday and the second incident occurred

after is birthday. This answer was in response to Saldana's question as to when these incidents occurred; before his birthday or after. When these incidents occurred with Crystal VIC-1 had his clothes on, but Crystal was naked except for a pair of boots she was wearing. Both of the incidents with Crystal were exactly the same. VIC-1 stated the same type of incident occurred with his father two times in the restroom and both times were exactly the same.

When Saldana asked VIC-1 to tell her everything that happened with his father he appeared to become exasperated that he had to explain it to her. VIC-1 disclosed that while at his father's residence his babysitter kicked him and punched him on one occasion when he was seven years old. VIC-1 was unable to provide any details about this incident. VIC-1 was unable to provide details about the incidents with his father and Crystal. Even though these acts allegedly occurred when he was seven years old or sometime just before he was even years old, VIC-1 was only able to tell of the act itself with no detail when asked. The same was for the alleged assault by the babysitter VIC-1 disclosed at the end of the interview. During the interview VIC-1 never disclosed anything referring to his father being called "Master Bobby.

18 The following is only a synopsis of VIC-2's interview. Refer to the DVD for further detail. VIC-2 disclosed her father touched her on her vagina with his hand over her clothing. This 19 20 occurred when VIC-2 was five years old. The incident occurred at her father's house in his 21 bedroom. Crystal was also in the bedroom, but was lying on the bed watching television. Her 22 father was wearing a shirt and blue jeans and VIC-2 stated she was wearing clothes like she had 23 on during the interview. VIC-2 identified her private parts as where "pee and poop" come out of. 24 The body part where her father touched her was where "pee" comes from. VIC-2 also disclosed 25 Crystal had touched her the same way her father touched her. This also occurred in the bedroom, 26 but on a different occasion. VIC-2 stated her father was bad and Saldana asked her why he was 27 bad. VIC-2 stated he was bad because he had given her rotten apples to eat. Saldana asked her 28 what was the "baddest" thing her father had done to her and she said it was when he pulled her 29 bed away from her and she fell to the floor. Saldana asked VIC-2 if anyone else has touched her 30 and she said no one had.

After the interviews were completed I advised Angelina both children had made disclosures. I discussed a pretext telephone call with her, but after speaking with her, I concluded the pretext could not have worked with Angelina as the caller. Angelina told me there was no one else she knew who could do it.

On 12/21/2015 at 0830 hours, was interviewed at Project Kids by SW Jackie Saldana. During the interview did not make any disclosures reference any type of abuse.

On 01/15/2016 at approximately 1130 hours, I contacted Bobby at the Jurupa Valley Station to obtain his statement reference these allegations. Also present during the interview was Bobby's attorney, (OTH) Joyce Holcomb. The following is only a synopsis of Bobby's interview. Refer to the DVD for further detail. I gave Bobby a Beheler admonishment, which he stated he understood. I asked Bobby if he is or ever has sexually abused his children or Crystal's and he replied he has not. I asked him why his garage was locked during the CPS visit. Bobby explained the garage had construction materials inside it due to a water leak that occurred on the second story of his residence. He didn't have the key because he had given it to a neighbor so the construction crew could be let in when Bobby was at work. Bobby had offered to CPS to return later that evening on 11/24/2015 to inspect the garage, but they declined. Bobby stated he turned the garage into a workout area. I asked Bobby why did he rent a U-Haul on 11/28/2015 and he replied because he doesn't own a pick-up truck, He rented it so he could get rid of all the construction debris since the work was completed. Also, he had to pick up an elliptical machine for Crystal (Bobby later gave me receipts for the U-Haul and the elliptical machine).

I asked Bobby if he was part of a sex club called the Red Dragons and/or was into any sexual practices involving whips and or chains or sex tools of that type. I asked Bobby if he had any male only parties at his residence and he replied he did not. He stated he has had a few parties at his residence like for a fight or sporting event. Bobby said he was not part of any sex club and wasn't into that type of sexual activity. I asked him if he watched pornography and he stated he did on his laptop and he would watch it with Crystal. I asked him what type of pornography he

watched and he said the normal type. I asked him if he watched any type of child pornography and he replied does not.

At the conclusion of the interview I asked Bobby if he would be willing to participate in a polygraph examination, which he replied he would. I later scheduled a polygraph examination for Bobby to take place at the Jurupa Valley Station on 01/27/2016 at 1130 hours. The examination would be administered by Ryan Angulo of the County of Riverside Human Resources Polygraph Unit.

On 01/21/2016 at approximately 1415 hours, I contacted Crystal Turner at the Jurupa Valley Station to obtain her statement reference these allegations. Also present during the interview was her attorney, Joyce Holcomb. The following is only a synopsis of Crystal's interview. Refer to the DVD for further detail. I gave Crystal a Beheler admonishment, which she said she understood. I asked Crystal if she ever sexually abused her children or Bobby's children and she replied she has not. I asked her why the garage was locked during the CPS visit. She explained the garage had construction materials inside it due to a water leak that occurred on the second story of Bobby's residence. Bobby had given the key to a neighbor so the construction crew could be let in when they were at work. Crystal stated Bobby rented a U-Haul to remove the construction debris from the garage and to pick up an elliptical machine for her. I asked her if she watched pornography and she stated she watched it with Bobby. I asked her if she watched any type of child pornography and she replied she did not. I asked her if the children had ever seen any of the pornography they watched or had they left it on where the children could have seen it and she replied no to both questions. I asked again asked Crystal if she had ever sexually abused her children or Bobby's and she replied she had not.

On 01/27/2015, Bobby was administered the polygraph examination by Angulo. Bobby replied "No" to both of the following questions. "Have you had sexual contact with either of your children?" and "Have you had sexual contact with either of your children in your home?" After the tests were completed I was informed by Angulo that Bobby was found to be *truthful* in response to the two questions Angulo asked Bobby reference the allegations.
