#### **DETAILS:**

- 2 On Tuesday, November 24, 2015, Deputy Jackson and I were on uniformed patrol in the City of Eastvale.
- 3 At 1506 hours, we were dispatched to 13876 Fair Meadows Court, Eastvale, reference assisting Child
- 4 Protective Services with a possible sexual assault (Reference CPS #1230-1068-8881-9042257). Once on
- scene, I contacted (OTH) CPS worker Olivia Baker, and (OTH) CPS worker Tiffany Bedoy, who told me
- 6 they received a referral for sexual abuse allegations involving (OTH) Bobby Harris and (OTH) Crystal
- 7 Turner, that occurred at this location.

- 9 Baker informed us we were there to observe, and in case an arrest was required. Deputy Jackson and I
- accompanied Baker and Bedoy inside the residence and observed as the home inspection was conducted.
- After the inspection, Baker and Bedoy conducted interviews with Bobby, Crystal, (
  - and while Deputy Jackson and I observed.

- Baker advised us she would be writing a report, but did not see any signs of potential abuse. I also did not
- 15 hear anything that appeared criminal in nature, and advised Bobby and Crystal I would only be
- documenting the incident.

- 18 At 1957 hours, Deputy Jackson and I were dispatched to Kaiser Permanente Hospital in Riverside,
- 19 reference a past sexual assault at 13876 Fair Meadows Court. The reporting party was a social worker at
- 20 the hospital. We arrived at 2101 hours, and contacted social worker (OTH) Kathleen Huerta who told us
- 21 the following:

22

- 23 Huerta said (OTH) Angelina Harris was there stating VIC-1 and VIC-2 had been sexually abused by
- 24 Bobby Harris. Huerta said she talked to both victims separately, and VIC-1 did not say anything about
- being touched sexually. It also appeared as though both victims were potentially coached on what to say.

- 27 At 2112 hours, Deputy Jackson and I met with Angelina, VIC-1, and VIC-2 in exam room 10, in the
- 28 Pediatric Center at the Kaiser Permanente Urgent Care Unit. We informed Angelina we needed to speak
- with her, VIC-1, and VIC-2 individually, and she agreed.

- At 2117 hours, Deputy Jackson and I spoke with VIC-1 regarding the allegations. While talking to VIC-1,
- 2 Deputy Jackson asked if he knew the difference between telling the truth and telling a lie, which he did.
- 3 Deputy Jackson then asked if he knew what private parts are and where they are located. VIC-1 said,
- 4 "Yes," and pointed to his penis and his buttocks. Deputy Jackson asked VIC-1 if anyone had ever touched
- 5 his private parts and he said, "No." VIC-1 was very cheerful while speaking with us. Deputy Jackson
- asked VIC-1 once more if anyone touched his privates, and he said, "No." VIC-1 had nothing further to
- 7 add regarding the incident.

- 9 At 2123 hours, Deputy Jackson and I spoke with VIC-2 regarding the allegations. While talking to VIC-2,
- Deputy Jackson asked if she knew the difference between telling the truth and telling a lie, which she did.
- Deputy Jackson then asked if she knew what private parts are and where they are located. VIC-2 said,
- 12 "Yes." Deputy Jackson asked VIC-2 if she could point to her private parts and she said, "No. I could but I
- 13 won't." Deputy Jackson pointed at her groin area and asked VIC-2 if it was a private part. VIC-2 said,
- "Yes." Deputy Jackson then pointed at her buttocks and asked VIC-2 if it was a private part. VIC-2 said,
- 15 "Yes." Lastly, Deputy Jackson pointed at her breasts and asked VIC-2 if they were private parts. VIC-2
- 16 said, "Yes."

- Deputy Jackson asked VIC-2 if anyone had ever touched her private parts and she said, "Yes, daddy does.
- 19 He makes me but I don't want to." Deputy Jackson asked what he makes her do and she said, "He makes
- 20 me touch his but I don't want to." Deputy Jackson asked where his private part is and VIC-2 said she did
- 21 not want to tell her. Deputy Jackson pointed at her groin area again and asked if that was where his private
- 22 part was, and VIC-2 said, "Yes." Deputy Jackson asked VIC-2 how he makes her touch his private part
- 23 and she said, "He grabs my hand and makes me touch it."

- Deputy Jackson asked VIC-2 if she loved her daddy and she said, "Not really cause he's about to go to
- 26 jail." Deputy Jackson asked VIC-2 who told her that and she said, "My mommy." Deputy Jackson asked
- VIC-2 if she would be sad if she never saw her dad again, and she said, "No I would be happy. He always
- does mean things to me." Deputy Jackson asked VIC-2 what kind of mean things her dad does to her, and
- 29 she said, "I don't know, I don't remember."

- Deputy Jackson asked VIC-2 again if her dad touched her private parts, and she said he touched her
- 2 vagina, "Once." Deputy Jackson asked VIC-2 how long her dad touched her vagina and she described it as
- quick tap. Deputy Jackson asked VIC-2 if she wanted her dad to go to jail, and she said, "Yes." Deputy
- 4 Jackson asked VIC-2 if she knew Crystal, and she said she did and that she, "touched me the same way my
- 5 daddy did." VIC-2 had nothing further to add regarding the incident. While Deputy Jackson was speaking
- 6 with VIC-2, I noticed how unconcerned she was.

7

- 8 At 2138 hours, Deputy Jackson and I spoke with Angelina regarding the allegations. Angelina said there
- 9 were no signs of sexual abuse while her and Bobby were married, but there were some signs regarding
- VIC-2 after they split up. Angelina said that Bobby has a sex addiction that he has seen a counselor for.
- Angelina said CPS came out to their house in April, but the allegations were unfounded. Angelina was
- being very descriptive when describing the alleged sexual abuse between VIC-2 and Bobby. Angelina
- stated that VIC-2 described Bobby's penis and used her arm to show how big his penis was. She also said
- that VIC-2 told her she, "has had to put her mouth on [Bobby's] penis." Deputy Jackson asked Angelina if
- she told VIC-2 that Bobby was going to jail, and she said, "No." Angelina said that she and Bobby met
- with the counselor at VIC-1 and VIC-2's school, and when the counselor said he spoke with the victims,
- 17 Bobby seemed very uncomfortable and demanded he be at all meetings between the victims and
- 18 counselors. Angelina said whatever tests or interviews need to be done, that she is willing to have the
- 19 victims go through them.

20

- I provided Angelina with my business card, contact information, and the file number. I advised her that I
- 22 would be forwarding this report to the Jurupa Valley Detectives for further follow up. Angelina said she
- 23 understood and had nothing further to add regarding the incident.

- 25 This report will be forwarded to Jurupa Valley Detective for further investigation of a possible sexual
- 26 assault.
