10	I, ANGELINA RAYLENE VILLA, declare I am the Respondent in this action and have	
11	knowledge of the facts stated herein. I have personal knowledge of the facts I state below, and if I were to be called	
12		
13	as a witness, I could competently testify about what I have written in this declaration.	
14		
15	Summary of Recent Events	
16	In 2015 I reported the sexual and emotional abuse of my children. They claimed to have been	
17	filmed by their father and a group of men and women. We have lived the past nine months in Austin and I have	
18	given them access to regularly therapy and medical help to address the emotional disturbances from alleged abuse.	
19	Our lives have been disrupted, we have been displaced from our safe home environment and	
20	access to care in Austin, and our freedom to live freely and peacefully without the threat of criminal abuse has been	
21	taken away. It was ordered on March 17th, 2017 that I either abandon my children and give over full custody to their	
21	father who they allege abused them with a group on film, or face felony criminal charges.	
	I am not a criminal. I have never been convicted of a crime. Nor have my children, or anyone else	
23	for that matter, claim that I have abused them or that they are not safe in my care. None of that can be said for the	
24	Plaintiff.	
25	I retained representation from two attorneys in Austin. Attorney Harris contacted Joyce Holcomb	
26	and Jennifer Gerard on April 10, 2017 to request a continuance for the April 11th hearing. They did not agree to	
27	continue, so she arranged for a local attorney to appear in her stead. Her email to me with the subject line is attached

as Exhibit A. Hours later she withdrew from the case, and I appeared by telephone to represent myself for the 2 scheduled April 11th hearing.

3 Attorney Carver scheduled an ex-parte hearing to protect my children from being extradited from 4 their home in Austin to a dangerous situation. Joyce Holcomb referred to this hearing in court and said she would 5 appear by phone. Later that afternoon, Attorney Carver withdrew from our case.

I do not know why appropriate action has not been taken in response to the serious allegations of abuse my children have made. And without willing and able legal representation, time allowed to present evidence and testimony from counselors, therapists, psychologists, medical professionals, and school staff who have aided our children over the last eight months, and when all criminal reports of abuse go back to Riverside County Sheriff department for investigation. I see no legal remedy to keep our children from harm in Riverside, CA.

11 I do not understand why Judge Firetag and Attorney Gerard were so quick to remove our children 12 from my custody without investigating evidence from Austin Texas. But I can wholeheartedly claim that as their 13 mother, I cannot be coached, bought, or threatened to subject my children to further criminal abuse. They have been 14 through enough. Separating them from their only safe parent, and access to protective advocates will have long 15 lasting negative effects on their lives and mine for many years to come.
